## Re: Fuel surcharge for November 2022

The Department of Mineral Resources and Energy has published the latest fuel adjustments for November 2022, showing an increase in the price of diesel by R1.43/litre and in the price of petrol by R0.51/litre.

As of 2<sup>nd</sup> November 2022, the wholesale inland price of **diesel** (50ppm) will increase to **R25.74/litre** and the inland price of **petrol** (95 ULP) will increase to **R22.87/litre**.

The escalation in **diesel** and **petrol** prices since January 2022 are staggering at **48,95%** and **16,62%** respectively.

Our standard fuel surcharge for **November 2022** will increase to **49,90%** (up from 47,48% in October 2022).

This hike has been attributed to the increase in international fuel/oil prices as well as the depreciation of the South African rand against the US dollar.

As a logistics business, a fair portion of our costs are fuel related and our fluctuating fuel surcharge is intended as a recovery against our actual fuel costs incurred. We will continue to do everything possible to achieve efficiencies within our business to limit this impact on our clients.

Different logistic service providers apply different models to recover these fuel costs e.g. fluctuating fuel surcharges and/or adjustments to minimum base rates etc. fuel surcharges should therefore never be looked at in isolation.
